
Report : DIVERSIFYING U.S. ACCOUNTING TALENT: A Critical Imperative to

 IMA and CalCPA (California Society of Certified Public Accountants), working collaboratively with research partners, contributors, and advisors, conducted a research study of diversity, equity, and inclusion (DE&I) in the U.S. accounting profession. The report presents an assessment of the current state of DE&I in the U.S. accounting profession through key survey findings and an in-depth, discrete look at each demographic focus area.

Report : Building Financial Reporting Resilience Through Collaborative Cloud-Based Solutions

- This report describes how short-term adaptions rooted in the COVID-19 pandemic can accelerate financial transformation with respect to corporate reporting. The report concludes that although new time-saving cloudbased financial reporting platforms were a relatively low priority for organizations pre-pandemic, interest in agility and the potential continuation of remote working—including the control and oversight process are bringing about renewed consideration of these systems.



- This report examines how technology is affecting finance in other parts of the world, specifically the Middle East and India, and changes in the finance function. It is based on three surveys conducted in these regions during 2019 and 2020, which provide insights into the state of technology in the finance function in the Middle East and India, as well as insights into current trends and the impact of the COVID-19 pandemic.







Chinese Enterprises Facing The Impact of The Covid-19 Epidemic - A Survey of Challenges and Responses

IMA® (Institute of Management Accountants) and the Shanghai National Accounting Institute (SNAI) partnered to conduct a survey of finance professionals in China in February 2020 about the challenges of facing the COVID-19 public health crisis.

Amid the COVID-19 crisis, the top three challenges facing these enterprises were poor cash flow, labor shortages, and reduced effective demand. Small and micronized enterprises lacked effective crisis response capacity and risk management mechanisms, which led to poor operational results. Despite this, more than 50% of respondents said they were "cautiously optimistic" about the complete resumption of business operations by the end of the first half of 2020.


